

# Supplement 3 to the Network Statement 2023

ProRail has adopted the following supplements and/or amendments to the Network Statement 2023, in accordance with the provisions of section 1.5.2 of this Network Statement.

# 1 Merger of RailDocs and Rail Data information portal into Rail Information Portal (section 2.3.10 and Appendix 23)

I. In the following sentence of section 2.3.10 Signalling systems:

"The driving instructions are available via the <u>Raildocs of ProRail</u> application.", the phrase

"the RailDocs of ProRail application" is replaced by "the Rail Information Portal application".

- II. In Appendix 23, item 4 Description of the application Traction Signs (WVK):
  - the text in row 3.1.2 after item a) is changed to:
    - a) A download of the Traction Signs (WVK) in PDF format via the <u>Rail Information Portal</u> application. By taking a subscription to the web portal, changes are communicated by means of an email message.
  - the text in row 6.1 after item a) is changed to:
    - a) A download of the Traction Signs (WVK) in PDF format via the Rail Information Portal application.

## 2 User restrictions due to shortened braking distances (section 2.4.7)

The current section 2.4.7 User restrictions 's-Hertogenbosch railway yard lapses in full and is replaced by the new text below.

### **"2.4.7 User restrictions due to shortened braking distances**

In the 2023 timetable, user restrictions due to shortened braking distances will apply at the following locations:

- 's-Hertogenbosch railway yard
- Track GF/142 of Warffum station, direction Groningen
- Track 422 of Loppersum station

At these locations, the signalling is based on a minimum braking distance of 300 metres at 5‰ downhill gradient at 40 km/h. This is based on a minimum braking percentage of 54%. The railway undertaking shall ensure that:

- its train drivers using 's-Hertogenbosch railway yard are familiar with the changed situation on site;
- its trains at the 's-Hertogenbosch railway yard have a braking percentage of (at least) 54%. In case a train has a lower braking percentage than 54%, the maximum speeds as included in the letter from the Transport Inspectorate dated 20 January 2020 with reference ILT 2020/3792 apply:

In addition to the above user restrictions, the following user restrictions apply to railway yards in the 2023 timetable in respect of stopping braking at speeds at 40 km/h and below:

- Westhaven railway yard for passenger rolling stock

At this yard, signalling i based on the following minimum braking distances at the specified maximum speed and gradient:


This is based on a minimum braking percentage of 54%.

The railway undertaking shall ensure that:

- its train drivers using 's-Hertogenbosch railway yard are familiar with the changed situation on site;
- its trains at the 's-Hertogenbosch railway yard have a braking percentage of (at least) 54%."

#### Regulation to be agreed upon

ProRail wishes to reach agreement on the use of the above railway yards in the Access Agreement via the General Conditions (see Appendix 5, Article 11.2).



I. In section 4.5.4.5 Ancillary systems, insert the following new row in Table 4.4 under the row "*RMS Client*":

- III. In section 4.8.1 "Changes to allocated train paths by the railway undertaking", the text after the third bullet "*Via RMS Client*," is replaced with "*Via Mijn Treinen (see section 5.3.1 and Appendix 23, item 40)*".
- IV. In section 4.8.4 "Cancellation of train paths by the railway undertaking", the text after the third bullet "*Via RMS Client;*" is replaced with "*Via Mijn Treinen* (see section 5.3.1 and Appendix 23, *item 40*)".
- V. In section 5.3.1, the "Train path" service is changed as follows:


- o In item 2.1 Description, after item a., insert "Mijn Treinen" application after "RMS Client".
- In item 5.1 Legal requirements, "*Mijn Treinen*" is added to the exceptions from item a that are not provided to titleholders not qualified as railway undertakings (see also point 3 of this supplement).
- VI. In section 6.2.4 "Scheduled running of freight trains", in the text after the fourth bullet, the phrase "Via RMS Client (tab GTI) (see item 12, Appendix 23)" is replaced with "Via Mijn Treinen (see item 40, Appendix 23)".

VII. In section 7.3.5.3.3 "Submitting of requests and ad hoc phase schedule"

• at the first bullet after "the LOA-Online system", the following new footnote (162 with renumbering of the following footnotes) is inserted:

"LOA-Online cannot be used for requesting ad hoc shunting and/or stabling capacity at Kijfhoek. Capacity requests for the Kijfhoek shunting hump can be made in Donna, the Order Portal.or via telephone contact between the titleholder and traffic control."

VIII. In section 7.3.5.3.7 "Unused capacity and cancellation of allocated capacity", the following sentence is deleted:

"Capacity can be cancelled by sending a message to <u>capaciteitsverdeling@prorail.nl</u> or I or by deleting a volume infrastructure (VII) entry in Donna."

This text is replaced with the following passage:

**ProRail** 

"Cancellation of stabling and/or shunting capacity directly related to a train path can be done in several ways:

- With a TSI path-cancellation message (see section 5.3.1 and Appendix 23, item 21).
- Via the LOA-Online system (see section 5.3.1 and Appendix 23, item 11)<sup>2</sup>
- By deleting the train path and associated stabling and/or shunting capacity in Donna (section 5.3.1 and Appendix 23, item 6);
- By sending a message to capaciteitsverdeling@prorail.nl."
- IX. In the summary table at the beginning of Appendix 23, in the line on RMS Client, both footnote 189 and the addition "*Real-time information on the planning and intervention of scheduled train paths for freight traffic*" lapse.


"To titleholders who [...] of the part of this service indicated under 'description'."

This text is replaced with the following passage:

"Titleholders who do not qualify as railway undertaking can exclusively acquire from ProRail the items a (with the exception of the LOA-Online and Mijn Treinen applications) whereby a maximum of eight accounts can be purchased on Order Portal, b and c (only the RailMaps application) of the part of this service indicated under 'description'. With regard to the Capacity requests and Planning and performance information according to TAF/TAP TSI standard service, the titleholder shall, on the basis of Article 6 of the General Terms and Conditions, be given access to all planning and performance information of the railway undertaking concerned, which has agreed to this at the request of the titleholder."

# 5 Minor changes to the description of some ICT and information services (various sections and Appendix 23)

- I. In Appendix 23 item 6, Description of the **Donna** application, at item 5.1 in the table, the reference to Article 7 of the General Conditions is changed to Article 6.
- II. In Appendix 23 item 10, Description of the Path Coordination System (PCS) application, at item 6.1 in the table, the details of the ProRail One-Stop-Shop are replaced with "Via RailNetEurope: <u>https://cms.rne.eu/content/pcs-user-account-request.</u>"


